2. APPLICATION SUBMISSION

Following the investment, our legal team will begin the application for the main investor and spouse, undertake due diligence and prepare all the supporting documentation. On submission of the Golden Visa application will also be applied. Every adult applicant is required to apply from the country of residence.

3. APPROVAL IN PRINCIPLE

The time frame set by the Government for the examination of the Golden Visa application is 3 months from submission. At this stage you will receive an 'in principal' approval certificate.

4. BIOMETRICS AND COLLECT GOLDEN VISA (RESIDENCE PERMIT)

Biometric data will need to be submitted, this can be done during a further visit to Spain after Golden Visa approval. Crossing border based on Spanish visa or other Schengen country residence permit. It is also possible at this stage for investors to collect their residency permit cards.
